Definitions:

- Current Product- Any Boondocker product that is offered during the current season year. (ie ATV, Dirt bike, Snowmobile.)
- Obsolete Product- Any Boondocker product that is not offered during the current season year.

Pricing:

- Product must be at the Suggested Retail price unless discounted by the dealer.
- Non-Current year season product is at the dealer's discretion.

Discounting:

- Current model year production Boondocker Kits may not be discounted to less than suggested retail. Pricing on obsolete product is always at the dealer's discretion.

Dealer Sales Standards:

- 20 % Dealers should initially stock Three (3) kits, One (1) dealer service kit and signs with banners as required in the advertising section listed below.
- 30 % Stocking Dealers should initially shelf Ten (10) kits, One (1) pump refill station, One (1) dealer service kit and signs with banners as required in the advertising section listed below.

Advertising:

- Dealers must have a dealership presence and clearly identify themselves as a dealership for Boondocker products on all of their advertisements and on their websites. (Dealership logo, contact info, banners, window signs etc.)

Terms:

- Terms subject to credit approval. All payment terms are from ship date, COD, Credit Card, or Check.
Past Due Accounts: At 10 days past due, account will be on accounting hold pending payment.

Shipments:

- Any special shipping requests (over-night, etc.) need to be in advance and specified by the dealer.
- No Drop shipments outside of the U.S.

Return Allowance: ALL RETURNS MUST HAVE A Return Authorization

- Returned product must be authorized and have a return authorization number. A return authorization is valid for 15 days only. All turned product may be subject to a 20% restocking fee at our discretion. Returns are for exchange or in store credit only. Boondocker will not accept any returns on special order items. All product must be returned within 10 days of the delivery date and be accompanied by original invoice. If the product has been used or installed or any of the components are missing, the product is non-returnable.

Cost of Collecting:

All accounts past due will be assessed finance charges equal to 4.5% per month on the past due balance and late fee of \$25.00 per invoice past due.

Personal Guarantee:

For the purpose of establishing a dealer relationship with Boondocker LLC and in consideration of the extension of trust by Boondocker LLC to the applicant named below including all costs and reasonable attorneys fees, and/or any undersigned waives notice for himself and the company of acceptance, notice of nonpayment, protest, and of notice protest with respect to the obligation covered herein. Title to merchandise remains the property of Boondocker LLC until paid in full. It is further agreed that in case of any status change concerning the applicants credit history and agrees to terms herein.

Acknowledgement:

By signing, the dealer representative acknowledges and agrees to all stipulations specified above. Furthermore, the dealer understands that by not adhering to these guidelines the dealer status will be revoked with no notice by Boondocker LLC and will no longer be authorized to purchase or sell Boondocker products for internet sales or retail.
